### Dear Contestant,

Due to the coming into force of the Regulation of the European Parliament and of the Council (UE) 2016/679 of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/WE (General Data Protection Regulation, hereinafter referred to as "GDPR"), we wish to inform you on the scope of processing of your personal data with regard to your application to take part in the 3<sup>rd</sup> Henryk Mikołaj Górecki International Composition Competition (hereinafter: "the Competition").

1. Personal data protection does not cover the data published by Facebook users on the fanpage [www.facebook.com/filharmonia.slaska](http://www.facebook.com/filharmonia.slaska)
2. The Controller of the personal data processed with regard to the organisation of the Competition is the Henryk Mikołaj Górecki Silesian Philharmonic in Katowice, with its registered office at the address: ul. Sokolska 2, 40-084 Katowice, Poland.

The personal data provided to the Organiser by the Contestants are processed in compliance with Article 6 Section 6 Letter f of GDPR for purposes resulting from legitimate interests of the Controller and shall be used by the Organiser exclusively for the purposes of the organisation of the Competition and to the extent necessary for such purposes. Providing personal data is voluntary; however, a refusal to provide them renders it impossible for the Contestant to be awarded in the Competition. Each Contestant has a right to view, rectify, and request to erase their personal data. Personal data shall be processed in compliance with the Regulation of the European Parliament and of the Council (UE) 2016/679 of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data
5. Contestants accept having their personal data processed by the Controller for information and archival purposes in promotional and advertising materials of the Controller. Telephone number, telephone, address of the Contestants shall be processed exclusively for contact and identification purposes. Data of the Winner in the Competition in the scope of their first name and surname, image registered in an audiovisual form or in a photograph may be published on the Controller's website and in social media.
6. Providing personal data is voluntary, but necessary for the Contestant to take part in the Competition. Data subjects have a right to access, rectify, or erase their data.

8. The data shall not be profiled nor transferred to any third countries.
